


## Fig.1 Power Dissipation Derating Curve


Fig.2 Maximum Safe Operating Area




Drain Current : -I<sub>D</sub> [A]









Fig.7 Breakdown Voltage vs. **Junction Temperature** 








## Fig.8 Typical Transfer Characteristics

## Fig.10 Forward Transfer Admittance vs. Drain Current









Fig.11 Drain Current Derating Curve

Fig.13 Static Drain - Source On - State Resistance vs. Junction Temperature









Fig.14 Static Drain - Source On - State Resistance vs. Drain Current (I) Fig.15 Static Drain - Source On - State Resistance vs. Drain Current (II)

Fig.16 Static Drain - Source On - State Resistance vs. Drain Current (III)








Fig.17 Typical Capacitance vs.

## Fig.18 Switching Characteristics




Fig.19 Dynamic Input Characteristics






Fig.20 Source Current vs. Source Drain Voltage






